

IN A PANIC

"This was her worst fear — another marriage ending," a Kardashian source says of Kim (with North). "And this time, a child is involved."

The evening turned into a nightmare before they even stepped out of their limo. Kim Kardashian and Kanye West were headed to a *DuJour* magazine party in LA when a huge fight broke out between them. "Kanye, as usual, had been trying to control everything: what Kim would wear that night, how they would walk, where they would kiss," says a Kardashian family insider. "Kim finally had enough of being his puppet. The fight was so bad that she wouldn't even get out of the limo, so



"It's going to get ugly in that courtroom," says an insider close to the feuding couple.

DIVORCE COURT DOWN

Kanye attended the party all on his own while Kim sat brooding in the car for 45 minutes waiting for him to come out."

Things are about to get a lot worse for her. "Kanye is done with their marriage and wants out right away," says a source close to the couple. "The marriage has become more like a business deal, and he doesn't want to pretend anymore. He wanted a child and he got that, but now he knows there's nothing left between him and Kim. He's going to file for divorce — and drag her to court."

That will open the door for Kanye to expose everything Kim is so desperate to hide. "On the witness stand, he could reveal that she has a revolving door of four to five nannies who do all the heavy lifting with North," says a Kardashian source. "She's not as hands-on a mom as she makes it seem." Kim, 34, didn't exactly make herself look like



HE'S DONE

"Kim's not respected," says a source, "and Kanye's beginning to realize her fame is not what he wants to be associated with."

THE LAST TIME WAS A NIGHTMARE!



After Kim left NBA star Kris Humphries 72 days into their marriage in 2010, it took nearly 18 months for her divorce to go through. "Kris felt duped by Kim, and that's why he sued her," says a source. He forced Kim to sit for a nine-hour deposition. Kanye and *Keeping Up With the Kardashians* producers (see below) were also grilled by his lawyers. "Kim never wants to talk about it, because she says it was the most embarrassing thing that's ever happened to her," says a family insider. "Now Kanye can put her through hell, too."

the mother of the year when she unapologetically cropped 19-month-old daughter North out of a photo she posted on Instagram on Dec. 15, explaining, "Her eyes were closed, and I was feeling my look!"

The shocking revelations about Kim's private life will keep coming. "Kanye's biggest secret weapon is the threesome they had with a female celebrity," says a source close to the couple, though Kim's rep denies it. While *In Touch* — which first reported the fling in November — has chosen not to publish the name of the celebrity in order to protect the woman, "it will definitely come out in court," adds the source. It would be a bombshell testimony. "Kim is terrified Kanye will tell the world what she did and who she did it with."

Until now, the pair have gone out of their way to fake it for the TV cameras. "They've tried to act like a happily married couple, but lately you can see the tension between them," says the Kardashian source. Kanye stage-managed every aspect of their over-the-top wedding for public consumption and carefully controls their image. "But there's no hiding it anymore. Kanye's through with her."

Kim has already consulted with a high-powered LA divorce attorney. But Kanye has the money and the connections to hire a top divorce attorney, too. "It could go on for a long time. You hear of divorces and custody arrangements taking years to be concluded," says an insider, who notes that Kim's divorce from second husband Kris Humphries took nearly 18 months — and they'd only been married for 72 days and didn't even have a child. (Kim and Kanye, 37, have been married for less than eight months.) "This is likely to be another one of those situations. Neither of them will be happy unless they get exactly what they want. It will be a really sad situation for North, since she'll be the one stuck in the middle of it all."

Kim and Kanye have a prenup to deal with their finances in the event of a split. But the docu-

ment, according to insiders, doesn't determine custody; a judge has to sign off on that. And while the marriage has been a sham, Kim and Kanye's love for North is very, very real, setting the stage for an acrimonious court battle filled with riveting testimony. And because of the couple's wealth, don't expect things to be resolved quickly, explains Mark B. Baer, a family law attorney and mediator, who has not advised Kim or Kanye. "They both have more money to fight with over the parenting plan. What ends up happening is the person who perceives to have lost that battle routinely goes back to court over and over instead of trying to work it out in the best interests of the child."

But if Kanye plays dirty, Kim will, too. "She'll hold nothing back," warns the family insider, who notes that Kanye and Kim still don't even

live in their own home and that he chooses to spend nights away from her. "She'll reveal how they sleep in separate beds and that he's always tried to control everything she did, from what she wore to where she

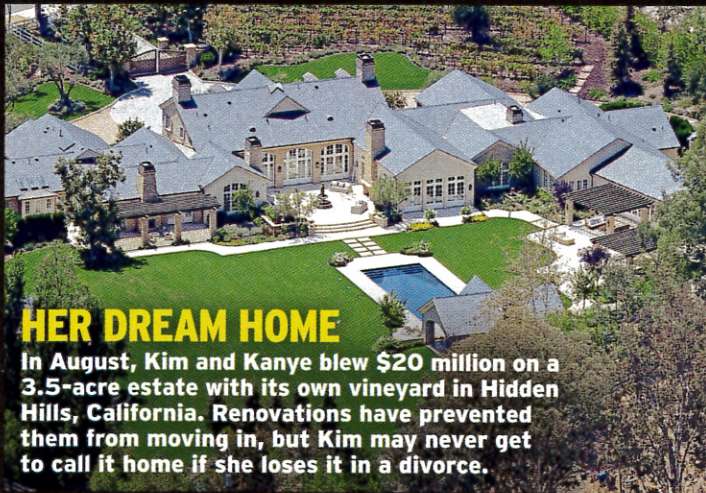

went to who she spent time with. I even heard she got pregnant by IVF! She'll also count the days he's spent with his daughter and try to show he's an absent father.”

There's one person who doesn't want the marriage to end: Kim's mom, Kris Jenner. "She doesn't want Kim to have another failed marriage under her belt. It's not good for the Kardashians' brand," says another source. "Kris' advice to Kim was to make it work with Kanye and get pregnant again as soon as possible."

The tense-looking couple were spotted leaving a medical center in LA on Dec. 23. Another baby right when their marriage is crumbling would definitely complicate everything. "But it won't stop Kanye from ending it," assures the family insider. "Kim is terrified it's going to be the Kris Humphries situation all over again and get very ugly. She had the upper hand with Kris, but this time Kanye has all the power because of what he knows. The last thing she wants is to be dragged to court." ■

HER DREAM HOME

In August, Kim and Kanye blew \$20 million on a 3.5-acre estate with its own vineyard in Hidden Hills, California. Renovations have prevented them from moving in, but Kim may never get to call it home if she loses it in a divorce.

"Kim stays in the marriage because she loves the idea of being a power couple and knows she can make more money as Mrs. West," says a family insider. "She's scared to death of losing everything."
